Subject: EERMC Client Fund: Reconciliation Status Summary

By conducting an internal audit of the EERMC client fund, the RI Office of Energy Resources discovered that the attached 2019 budget document underestimated the client fund total by \$116,233.80. Therefore, there is \$153,117.44 dollars in unallocated funds still available to the EERMC in 2019.

Through the audit process, it was discovered that a combination of at least two errors resulted in an underestimation of the client fund balance:

- 1. An incorrect rollover amount was used in the 2017 to 2018 EERMC budget spreadsheet. The spreadsheet showed a client fund balance of \$244,172.00 which was substantially lower than the actual client fund balance. This appears to have been a human error in transitioning from one spreadsheet to the next.
- Budgeted values rather than actual, contracted amounts were also used in some cases in the
 calculation of the remaining 2017 and 2018 client fund balances. This resulted in balance values
 that differed from the actual client fund account.

The investigation into the errors resulting in the wrong client fund balance being reported is still ongoing. However, the RI Office of Energy Resources is confident in the remaining, available funds shown here. The RI Office of Energy Resources will continue to review the client fund management process and will bring recommended changes to the full EERMC as soon as possible.
