

Section 5 of Bylaws:

Removal: The Executive Committee of the Council may recommend to the Governor the removal of any member who (a) fails to attend at least two-thirds (2/3) of the regularly scheduled meetings of the Council during a twelve (12) month period,

(b) fails to attend three (3) consecutive meetings of the Council or (c) fails to perform his/her duties in a manner consistent with the Council's mission and/or these by-laws; and/or any authorizing or companion legislation pertinent to the Council.
