

As of November 10th, the Commission and the Division have combined to issue 196 questions to Rhode Island Energy


No data requests have been issued to other parties, including the EERMC, to date

Data Requests



EERMC Budget Development Testimony

LCP Standards Chapter 6.2.H.b requires that the Council:

 "Provide testimony, reasonable documentation, and justification for the budget level to support a Commission allocation of the requested amount. The budget must reflect reasonable costs, be reasonably needed to carry out its duties, and be reasonably related to the expense types identified in the statute."

Includes description of Council's process for:

- Finalizing its 2023 budget following the PUC's rulings on the 2023 Plan in Docket 22-33-EE
- Developing its proposed budget for 2024

Includes a budget table which explains:

- Variances between year-end forecast and planned budget for 2023 that are +/- 10%
- Proposed increases/decreases in 2024 budget compared to 2023
- New items contained in 2024 budget
- Forecasted year-end spend for 2023
