#### **PURPOSE OF BRIEFING MEMO**

The purpose of this briefing memo is to assist Councilors with digesting the many materials and decisions they may need to make at each meeting. It follows a similar format to the official meeting agenda so Councilors can follow along throughout the meeting. For each agenda item, this memo will highlight key considerations for the Council and clearly indicate what actions (if any) the Council needs to take. The Consultant Team (C-Team) has worked with the Office of Energy Resources (OER) to also incorporate the content that Councilors are used to seeing in the "Recommended Vote Language" document. This ensures the Council has a single point of reference during meetings. This memo will also note any supplemental materials that are provided, but not associated with, specific agenda items. The C-Team and OER welcome any feedback on the format and content.

#### 6A. COUNCIL DISCUSSION WITH PIVOTPATH ON PUBLIC AWARNESS CAMPAIGN

#### **Key Considerations**

- PivotPath will share the efforts it has made so far, highlight key achievements, and outline future steps
- To date, work has focused on market research, objectives and messaging, and initial campaign concepts
- Future work will include developing a media plan, engagement goals, and campaign implementation

- Do you have a clear vision of where this project is and where it is going?

#### 6B. REVIEW AND VOTE ON THE DRAFT 2024 EEC ANNUAL REPORT

#### **Key Considerations**

- The Council is required to submit an annual report on its activities, assessment of energy issues, status of system reliability, energy efficiency and conservation procurement, and recommendations regarding any improvements which might be necessary or desirable
- The C-Team has developed the final draft of the Council's Annual Report, including support from Rhode Island Energy, OER, and feedback from Councilors
- Future iterations of the Annual Report will work to reduce the level of energy jargon to make it
  more accessible for broader audiences, and will be written with a more balanced tone when
  reporting on results of energy efficiency programs

# **Discussion Questions**

- Does the Annual Report meet the Council's expectations?
- Are there aspects of the report that could be improved for future iterations that haven't already been noted (e.g. those referenced in the last bullet under key considerations above)?
- Does the Council wish to revisit the overall format of the Annual Report prior to the development next year?

### **6C. COUNCIL DISCUSSION OF 2025 BUDGET PROPOSAL**

#### **Key Considerations**

The proposed budget:

- Maintains core items from 2024, such as C-Team and Legal Services;
- Removes funding to support the 2024 Farm Energy Fellow, as OER has secured funding for this
  position;
- Replaces K-12 Education with a Health Equity Zone (HEZ) Community of Practice; and
- Reduces support for the Energy Expo Sponsorship

The proposed budget represents a 3.5% decrease compared to the Council's 2024 proposed budget, and a 5% increase compared to the Council's 2024 budget that was approved by the Public Utilities Commission

# 7A. RHODE ISLAND ENERGY PRESETNATION ON TRANSPORTATION DEMAND SIDE MANAGEMENT PROPOSAL

#### **Key Considerations**

- Rhode Island Energy plans to file the second phase of its Electric Transportation Initiative with the Public Utilities Commission as a Demand Side Management Proposal
- Per the Least Cost Procurement Standards, which were revised in 2023, such a proposal requires that the Council have engagement and the opportunity to endorse the proposal (similar to the Company's recent Electric and Gas Demand Response proposals)
- The Company is providing an early overview of this proposal to the Council as it is a new item that the Council has not previously weighed in on

- Does the Council need additional information in order to make a decision about whether or not it would want to endorse this proposal?
